I understand that under Texas law (Chapter 87, Civil Practice and Remedies Code) an equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the risk of equine. I understand that I must ride/handle/drive in a safe manner. I further understand that I am signing this release and indemnifying for myself as well as for my children, and that these children have been offered animal safety instruction when required. I understand that in using this property, where known hazards exist by generally common accepted fact, that myself and any member of my family are assuming whatever risks and hazards are generally involved in the participation of this activity.

In consideration of permission to participate in this Event, I hereby waive all claims for damages or injury to myself or to my family and to indemnify and forever hold harmless the Southwestern Donkey & Mule Society, any property owner of facilities included in the event, and their agents against any loss, cost or judgment of any nature for such damages or injury that might occur to myself or any member of my family who choose to participate in this event whether or not such damage is caused by negligence, carelessness, defects in equipment or facilities, whether latent or patent or by any other cause whatsoever. I understand no one is authorized to make statements or representation either verbally or written, which in any way contradicts this waiver and release of claims.
